## Re: Call for Bids NS13-1

My name is John Couture and I am employed by the Unama'ki Institute of Natural Resources in Eskasoni, Nova Scotia. I was asked to attend the FAC meetings held by the Canada-Nova Scotia Offshore Petroleum Board to provide feedback to these five communities.

As Mi'kmaq, we have an inherent right to access and use our resources and we have a responsibility to use those resources in a sustainable way. The Mi'kmaq way of resource management includes a spiritual element that ties together people, plants, animals, and the environment.

I have read through a large amount of reading scientific publication regarding seismic activity and the long-term sustainability of commercial fisheries after such activity. One document for example was *DFO's Review of Scientific Information on Impacts of Seismic Sound on Fish, Invertebrates, Marine Turtles and Marine Mammals*, which spoke to the significant level of uncertainty. There seems to be a lack of expertise seeking the long term impact particularly on the physiological damage to Snow Crab and other species, which are the most significant species being fished by Unama'ki communities.

I would like to clarify for the record that the comments provided regarding this call for proposals is *NOT* consultation or part of a process of consultation.

The Crown has a constitutional duty to consult with the Mi'kmaq of Nova Scotia when it is considering a decision or matter that may result in the infringement of the constitutionally protected Aboriginal or treaty rights of the Mi'kmaq or have some impact on Mi'kmaq rights.

In summary, I would like the Canada Nova Scotia Offshore Petroleum Board to *NOT* permit any seismic activity in these six parcels of ocean (NS13-1), until there is scientific evidence that no risk to species, habitat, and sustainability have been established.
